- b) County Councillor: Dave Wood reported .. *Gypsy/Traveller Short Stay Sites Public Consultation, had been closed. Further sites had been suggested/offered so matters would be reconsidered before being sent out again for public consultation.
 - *Road markings along the Strand were under review. He thought it unlikely that cat's eyes would be fitted on B roads
 - * Overgrown Hedges Dave suggested that the Parish Council write to the offending property owners and then to Suffolk CC if matters were not sorted.
- * PC Fulcher arrived in place of PCSO Adams and reported on the recent speeding through Woolverstone, where a number of cars were caught. He answered questions and took his leave.
- c) District Councillor: Written report (See Circulation Bag and website for full report).

 *Review the planning process the objective is to speed-up the whole process, so that low-complexity applications (the majority) can be passed on a predominantly 'tick-box' basis, unless there are local objections. For more complicated applications there will be increased emphasis on pre-application activities and local consultation. A new software system will accompany the new processes, the main impact being that all consultation will be done on an electronic (rather than a paper) basis. We expect that prints of plans will still be available on request but details have still to be worked out. There is no published definitive timescale for all of this but an announcement of the revised processes is expected by end-2014.
 - *'Back to basics' review of activities to assess the extent to which current activities contribute to the recently identified priority BDC outcomes, and if these activities could be done more effectively /efficiently. Results expected during late-Autumn.

*Council Offices Accommodation Review - being undertaken at present, recommends in general terms what should happen to the existing buildings (Hadleigh and Needham Market), but there is a lot of other work still to be done after that, e.g. looking at impacts on the local economy of any change, what new office facilities are required to support contact with the local population as well as back-office activities, as well as knock-on impacts of the above. *Freston Cross Roads - Freston Parish Council have organised a public meeting to discuss Freston cross-roads, on Friday 5th September. Cllr Graham Newman- Cabinet Member for Roads, Transport & Planning at SCC has kindly agreed to attend a meeting to discuss this topic. The meeting will start at 19.00 in Freston Village Hall (open from 18.40) for tea/coffee. *Benefit & Money Talk - Ipswich CAB are giving a series of talks this autumn about benefit entitlements. Of interest to our ward is the session on Friday 17th October (10:30-12:00 in Chelmondiston Village Hall).

Alterations to the roof, roof lights, windows and internal layout to the former bungalow extended under planning permission B/07/01737/FHA.

The Committee recommended SUPPORTING the application.

B/14/00865/FHA: Rivendell, Hollow Lane, Chelmondiston, IP9 1HZ

Erection of single-storey front extension.

The Committee recommended SUPPORTING the application.

B/14/00901/FHA: Shore Cottage, Pin Mill, Chelmondiston, IP9 1JR

Erection of a two-storey rear extension.

Observations discussed:

- the property is within the Conservation Area of a renowned Suffolk landmark and the AONB (see Policy CN08):
- gross overdevelopment in both scale and inappropriate non-matching window design;
- viewed from the R. Orwell proposed extension will tower above the original 'old' cottage and its later extensions;
- it is not seen to make a positive contribution to the character of Pin Mill (see Policy CS15);
- main issue: the proposed extension, can be construed as a new, two-storey dwelling attached to the existing property; described in the Design and Access Statement, as an 'outbuilding with an internal link to the cottage";
- continued promotion of the use of black weatherboarding.

The Committee recommended REFUSING the application

The Committee also considered and agreed with Babergh DC's Conservation Architect's original observations that the proposal "had the potential for overdevelopment, creating a third block appended to the existing and its more recent extension." He was concerned, as was the Committee, of a possibility to sub divide at a later date. The Committee did NOT agree with the Architect's later comment (after further consideration of the plans) that the "proposed extension would be subservient to the host dwelling and read as a *linked outbuilding* for which he would support the proposal.
