Cllr R Kirkup had spoken for the Parish Council against the application. As discussed at the Parish Council meeting on 3<sup>rd</sup> December 2013 and in support of Woolvertone's submission, the Parish Council had sent a request that the Secretary of State "call-in" the application for a more considered opinion. The Secretary of State on 5<sup>th</sup> December issued an Article 25 Direction to Babergh District Council, which directs the Council not to grant planning permission without specific authorisation. This is to provide the Secretary of State with a period of time to consider the question of "call-in".
