The BDC Planning Committee date for application DC/20/03247 is due to be considered on the 04/11/2020. However, the planning officer allocated to the application suspects that the agent/landowner may wish to address some of the issues raised in the public consultation with the district council. If this is the case, the application would not be considered on the 4^{th} of November as planned and the application would once again go to public consultation.

The member of public requested to know why the Cycle Path from Woolverstone to Chelmondiston was not supported by the Planning Committee and whether the parishioners had been consulted prior to the decision being made by the Committee.
